

*on September 10, 2004*  
**THIS MATTER** having been opened to the court by Burke & Potenza, P.A., (John Burke, Esq., appearing), attorneys for petitioner New Jersey Property-Liability Insurance Guaranty Association ("NJPLIGA") by way of Verified Complaint, Certification of John Burke, Esq., and Affidavit of Lori Connors, Esq., Claims Manager and counsel of NJPLIGA, and the court having entered an order to show cause with temporary restraints staying all proceedings in the State of New Jersey where State Capital Insurance Company is a party or is obligated to defend a party until September 10, 2004, at which time all objections to the entry of an order staying such proceedings for a period of 120 days *nunc pro tunc* to June 21, 2004, would be heard, and the court having considered the papers in support of the order, as well as papers submitted by counsel in a matter entitled *Smith vs. Cole, et al*, Docket No. MID-L-9198-02, requesting relief from any proposed stay, and the court this date entering an Order exempting that matter from the stay provisions of this Order for *which is codified by a separate order entered this date* certain limited purposes, and the Court having otherwise received no objection to the entry of an Order generally staying all such proceedings pursuant to N.J.S.A. 17:30A-18, and for good cause having been shown and due deliberation having been had herein, and the

court's reasons having been expressed on the record of the court,

IT IS ON THIS 15th DAY OF September, 2004;

**ORDERED** that all proceedings pending in the State of New Jersey in which State Capital Insurance Company is a party or is obligated to defend a party not otherwise exempted from the provisions of this order by separate order of this court, are hereby stayed until October 19, 2004, and it is further,


**ORDERED** that any request for a further stay of any such proceeding shall be made by motion filed by counsel for the party seeking the stay, in the county in which that proceeding is pending, on notice to all parties to that proceeding and to NJPLIGA, and it is further,

**ORDERED** that all such motions shall be decided by the Civil Presiding Judge of the vicinage in which the motion is filed, or that Judge designated by the Civil Presiding Judge, and it is further,

**ORDERED** that a copy of this order shall be served upon the Civil Presiding Judge and the Civil Division Manager of each vicinage in this state on or before September 27, 2004 and it is further,

**ORDERED** that a copy of this order shall be published in the New Jersey Law Journal, the New Jersey Lawyer, the Newark Star Ledger and the Courier Post no later than September 27, 2004.
